

Membership Terms and Conditions

Terms and Conditions ("Terms")

Last updated: 15 December 2017

These Terms and Conditions ("Terms", "Terms and Conditions") must be read and understood before purchasing the BOOTSTRAPPED Membership. It is the "purchasers" responsibility to understand the terms prior to your membership application. Your access to and use of the Membership is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who access or use the Membership.

Throughout these Terms, the terms "Bootstrapped", "us", "we" and "our" refer to Bootstrapped and its associated entities, and "you", "member" and "purchaser" refers to the individual or business purchasing the membership, "Third Party" refers to the Collaborators – Endorsed Service Providers.

By accessing or using the Membership you agree to be bound by these Terms. If you disagree with any part of the Terms then you may not access the Membership.

Membership

Entitlements:

As a member your entitlements will be listed on Bootstrapped's website. The entitlements will change without notice as some benefits are only available for a limited time. New benefits will be added throughout the course of the membership. We encourage our members to use the benefit whilst it is available, as it may not come up again in the future. We will try where we can to acknowledge the expiration date in the benefits section.

Application:

All applications of membership must be made via our website www.bootstrappedmembership.com. All information supplied at the time of purchasing the membership must be true and accurate. Bootstrapped reserves the right to decline or reject any application for any reason. Members will be approved and notified within 24 hours of purchasing.

Fee:

Bootstrapped reserves the right to amend the membership fee without prior notice.

The current fee will be stipulated on the website at the time of purchase.

Bootstrapped will not refund any difference paid by the Member if the Membership fee reduces during promotional periods.

The membership fee must be made by a single upfront payment on our website. Minimum commitment is twelve (12) months, after the initial twelve (12) months the member may choose to renew their membership. You will be notified approx. one month prior to the expiration of your membership term.

Your fee is non-refundable if you wish to cancel your membership prior to the first, and or ongoing twelve (12) month period.

Cancellation of Membership

Refunds

Privacy

without notice to you and has the right to block users to our pages.
